1. INVITATION FOR BIDS

- 1. Mangalore SEZ Limited (MSEZL) is jointly promoted by Oil & Natural Gas Corporation Ltd. (ONGC), Infrastructure Leasing & Financial Services Ltd., Karnataka Industrial Areas Development Board (KIADB) and Kanara Chambers of Commerce and Industries (KCCI). MSEZ Power Limited (MPL) has been incorporated to carry on the activities of Power distribution to various entities / units / Companies located in the Mangalore Special Economic Zone. MSEZL has taken up a project to set up a Sector Specific SEZ initially and is upgraded to Multi product SEZ catering mainly to the petrochemical industry and other sectors such as manufacturing, services, trading and warehousing (hereinafter referred to as "the Project").
- 2. MSEZL/MPL is issuing this bid document inviting sealed bids for the work "A) Operation & Maintenance of Grid Sub Station & Power Supply System in MSEZ including supply of spares; and B) Operation & Maintenance of Street Lighting System in MSEZ"- Contract Package No: MSEZL/O&M/POWER/2025. Bidding is open to all Contractors / Firms based in India, who are eligible as per technical requirements. Joint Venture is not allowed.
- 3. The intending bidders are required to make a onetime registration with M/s Karnataka State Electronics Development Corporation Limited (KSEDCL/KEONICS), the service providers for the e-tender by following the registration process on www.tenderwizard.com/MSEZ.
- 4. 6. Scope of work will be but not limited to the following:

Operation & maintenance of Grid Substation (GSS) & 110 KV transmission UG Cable & 33 KV & 11 KV distribution cables. The scope also includes 110 KV/33KV/11KV substation including 110 KV/33 KV switch yard, 110 KV Isolators, breakers, current transformers, potential transformers, earthing and lightning shield protection/ lightening arresters, 110/33KV-20 MVA transformers, 33/11KV-8 MVA transformers,

11/0.433KV- 250 KVA transformer, 250 KVA DG set, 33KV & 11 KV panels, battery chargers, SCADA System, control and relay panels, HVAC, cables, lighting masts, distribution system consisting of 11 KV RMUS and 33kv RMUs etc to provide power to individual industries /various plants of MSEZL. The scope of work includes operation and maintenance of all electrical, mechanical, instrumentation, civil works, for the entire grid substation & power distribution system, operation and maintenance of street lighting inside SEZ for the smooth and reliable operation of the system on 24X7 basis for one year, including all the following but not limited to:

- Provide all necessary skilled, semiskilled, unskilled manpower, of appropriate skills, required for 24X7 operation of the complete system as detailed.
- Uninterrupted 24x7 supply of power to SEZ through GSS.
- Operation and Maintenance of Street lighting System in MSEZ (R1 Road, R13 Road, R2 Road and ODC Road)
- Maintain log sheets at regular time intervals, necessary MIS for optimal performance during 24X7 plant operation and as determined by Engineer In Charge.
- Supply of all consumables;
- Carry out operation and maintenance.
- Repair & maintenance of transformers, isolators, breakers, control panels, etc., complete for smooth functioning of power supply.
- Maintaining SCADA system and all instrumentation equipments.
- Coordination with KPTCL/MESCOM/CEIG and other statutory authorities. Any Statutory charges paid towards this will be reimbursed by MSEZL/MPL on production of valid receipt.
- Maintenance of 33 KV and 11 KV distribution cable system including Ring Main Units
- Maintenance of 11 kV distribution, 11 KV and 1.1 KV cables, transformers and control cables and cable joints.
- Ensure compliance to all Environmental, safety, health and statutory norms at all times.
- Maintain good housekeeping and Hygiene conditions.
- Compliance of all statutory requirements including CEIG, PF, ESI, minimum wages, labour laws etc.
- Inclusive of all incidental items of work, except power charges.
- Coordination and comply with inspection from CEIG. Any repair/defects intimated by CEIG or any statutory authorities have to be complied through an agency who possess super grade licence or as per the statutory guidelines/requirements. Any Statutory charges paid towards this will be reimbursed by MSEZL/MPL on production of valid receipt.
- Checking monthly power consumption meter readings at consumer premises for proper energy auditing.
- The consumer energy meters are to be read positively on first day of every calendar month for raising monthly energy bill.
- Any tools, tackles, machinery, instruments required for identifying and rectification of faults are to be arranged for reduction of power interruption period
- Supply and installation of Major and Minor Spares. The supply and installation of major and minor spares of GSS 03 and power supply will be paid as per the rate quoted under Schedule B, C & D of BOQ. The supply and installation of major and minor spares of street lighting will be paid as per the rate quoted under Schedule Fof BOQ. The rate quoted shall be inclusive of all materials, labour, machineries,

consumables, tools and tackles etc required for replacement of spares

- Carrying out preventive maintenance. The payment for the same will be made under relevant item of BOQ.
- Preventive maintenance to be carried out for all the equipments as directed by Engineer in Charge and respective preventive maintenance has to be filled in and recorded.
- Arranging of cable fault locating machine and locating cable fault and rectifying the same.
- Providing one Bolero (A/C) with yellow board for 30/31 days per month for the MSEZL officials

Excluding the following:

- Power charges
- Diesel cost at the rate published by IOCL will be reimbursed on production of proper certified log of shutting of MESCOM power and running of DG by MSEZL/MPL. The payment will be made on a monthly basis. However, all other consumables including maintenance of DG will be in the scope of contractor.
- Raising bills to consumers
